

RESOLUTION No. 2015-20

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE NORTH TOOELE FIRE PROTECTION SERVICE DISTRICT TO ADOPT THE 2012 INTERNATIONAL FIRE CODE (WITH AMENDMENTS ADOPTED BY THE STATE OF UTAH) INCLUDING APPENDICES B, C, AND D.

WHEREAS, the North Tooele Fire Protection Service District (NTFD or the District) provides fire protection services to part of the unincorporated limits of the County of Tooele; and

WHEREAS, the Board of Trustees deem it necessary to adopt the 2012 edition of the International Fire Code (IFC), published by the International Code Council, including Appendices B, C, and D to provide for uniformity of requirements within the total District, to assist in the preservation of property and lives, and to promote the prevention of fire and damage within the District; and

WHEREAS, the Board of Trustees has considered the effect of fire code enforcement within the boundaries of the District and has determined that enforcement of the proposed codes would not cause undue hardship or suppression of economic growth within the District; and

WHEREAS, the Board of Trustees has studied the necessity for realistic and reasonable level of fire protection to be provided by a rural fire protection service district; and

WHEREAS, pursuant to Tooele County Code 6-18-3, the Tooele County Commissioners have previously adopted the 2006 edition of the International Fire Code and all future amendments to the code to be immediately included as part of the Tooele County Code and to be used as the standard in Tooele County; and

WHEREAS, a public hearing was regularly noticed up and conducted on November 19, 2015 to consider public comment on the adoption of the 2012 IFC Appendices;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the North Tooele Fire Protection Service District, to adopt the 2012 International Fire Code as adopted by the State of Utah, including Appendix B (Fire-Flow Requirements for Buildings), Appendix C (Fire Hydrant Locations and Distribution), and Appendix D (Fire Apparatus Access Roads) in their entirety without deletions, modifications, or amendments. All future amendments published by the International Code Council to the aforementioned code are to be immediately included within the provisions of this resolution without further action of the Board of Trustees. Additional amendments to the aforementioned code or new appendices that are deemed necessary will go through the public notification and approval process.

This resolution shall take immediate effect upon its adoption and approval.


